EHS Parking and Driving Regulations

- 1. All vehicles that park on school property MUST be registered with Campus Supervision. It is the driver's responsibility to update paperwork with new or changed vehicle information throughout the year.
- 2. All vehicles must park in one marked parking space in the proper student lot. Students must NOT park in visitor spots, staff lots, fire lanes, striped areas, no parking zones and/or restricted areas.
- A handicap parking tag or license plate and a valid EHS parking permit are required to park in handicapped spots.
- 3. The speed limit on school grounds is 10mph.
- 4. Students are not allowed to loiter in the parking lots or vehicles before, during, or after school.
- 5. Students are to notify the Colorado State Patrol and Campus Supervision of accidents involving vehicles. An accident report should be filed with Colorado State Patrol.

Parking permits are sold to licensed seniors and juniors only. All required paperwork and payment must be provided before a permit is issued. Due to limited parking spaces seniors will be given priority when purchasing passes. Juniors may purchase passes based on availability.

FEES and FINES

- 1. A parking pass costs \$125.00 per year and entitles the holder to park a vehicle that has been registered with campus security in the student lot on school days and during school sponsored events.
- 2. Parking fees are not refundable. If the parking permit is revoked, the fee is not refundable.
- 3. Lost permits must be reported immediately and replaced. A \$35.00 replacement fee will apply.
- 4. Tickets will be issued for violation of parking and driving rules. Violations include but are not limited to: failure to follow traffic signals, failure to visibly display parking permit, careless driving, speeding, parking in staff, recreation center, visitor, or non-designated spots. Prompt payment of fines is expected.
 - All parking and driving related fines accrued during the first semester must be paid before DECEMBER 10, 2014. Failure to do so will result in the loss of parking privileges for the second semester and the parking pass fee will not be refunded. The unused portion of the pass fee will be applied to any outstanding parking fines.
 - Juniors-All fines accrued during second semester must be paid before the summer break.
 - You will not be granted parking privileges the next school year if you fail to do so.
 - <u>Seniors</u>-Graduation caps and gowns could be withheld until all parking fines are paid.

IT IS THE STUDENT'S RESPONSIBILITY TO COMMUNICATE FINES WITH THEIR PARENTS. STUDENTS ARE RESPONSIBLE FOR FACILITATING RESOLUTION OF THEIR OWN PARKING ISSUES.

REVOCATION OF PARKING PRIVILEGES

Parking on campus is a privilege, not a right. Parking privileges can be revoked at any time due to disciplinary infractions determined by administration.

OTHER IMPORTANT INFORMATION

- 1. Permits must be prominently displayed and clearly visible.
- 2. Parking court is held every Thursday at the beginning of lunch in the Campus Supervisor's office. This is an informal chance for **STUDENTS** to dispute their parking fines.
- 3. Safety personnel direct traffic in our parking lot after school every day. Your cooperation is required to ensure the safety of our students, staff and community.
- 4. Parking permits are non-transferable. Students may not lend, give or sell parking permits.
- 5. Jefferson County Schools and Evergreen High School are not responsible for and assumes no liability arising from fire, theft, damage to or loss of the vehicle or any article left therein while on school property or in tow.
- 6. All vehicles parked on Jefferson County Schools' property are subject to search.
- 7. Vehicles must not drive across parking spots or the pedestrian walkway located in the center of the main parking lot to access other lots or to expedite departure.
- 8. EHS parking lots are designed to accommodate a single line of one way traffic. Please pay attention to the slant of the parking spots to determine the direction you should drive.
- 9. Drivers and pedestrians must refrain from using cell phones in the parking lot. Distracted driving is a ticketable offense.
- 10. Use light poles and common sense to properly align your vehicle in a parking spot when the lot is covered with snow.

Any violation of the above rules could result in loss of parking privileges, fines, vehicle tow and/or further school discipline.
